GUIDELINES FOR SUBMISSION OF FINAL PAPER:

All the interested authors are required to submit their final paper on or before 20th **April, 2014** (in .doc or .docx format) to the Editor (E-mail: colj@nluo.ac.in).

Submissions should include as succinctly as possible:

A separate title page which clearly indicates the name(s) of the presenting author(s) and other co-author(s), affiliation(s), complete mailing address(es), Telephone/fax numbers and e-mail address(es) and title of the paper shall be sent with the final paper. ***Deadline for receipt of final papers: 20th April, 2014.***

FORMATTING:

- **Margin** – Manuscripts must be in single spacing, font size 12 in Times New Roman/Garamond and all margins: 1.5 inches (left) and 1 inch (top, right and bottom).
- **Tables** – must be placed as part of the text. DO NOT attach tables at the end of the manuscript.
- **Software** – Manuscript must be submitted in MS Word form ONLY.
- **Title** – Written in uppercase, bold, size 14 and centered.
- **Author/s** – Name, address, email and contact number of all authors, font 12, Times.

- **Abstract** – Between 250-350 words “Times New Roman/Garamond” size 12.
- **Keywords** – should not more than FIVE keywords.
- **Title/sub-title** – Written in uppercase, bold, size 12 and left margin.
- **Tables/ Figures** – title of the tables/figure should be written on the top of the tables/figure. Times New Roman/Garamond, font 12, Bold, lower case, centered.\
- **Footnoting** – Footnoting should be done strictly according to 19th Bluebook. Font “Times New Roman/Garamond”, Size 10, Line-Spacing 1.
- **Word Limit** – Articles should be generally of 6000-8000 words (excluding references and footnotes). Editorial Board reserves the right to accept any article beyond this length if it deems fit.

Note:

- a) A declaration stating that the article submitted has not been published and/or is not under review to be published, by any Journal, Magazine, Publishing House etc., should be made and attached as a separate document with the article.
- b) Any article which is found to be plagiarized or if is having text match above the standards as fixed by the Editorial Board will be rejected out rightly.
