- ☞ The Bluebook (19th edition) or the MLA Stylesheet (8th Edition) is to be adhered to for citations.
- ☞ All Research Articles must be accompanied by an abstract not exceeding 300 words
- ☞ The submissions are to be made only in Microsoft Word Format (.docx or .doc files) by sending an email at [cslg.ilnu@gmail.com](mailto:cslg.ilnu@gmail.com). Email must mention the Subject as "CLG Research Article Submission" followed by title of the Research Article. Soft copies are to be submitted by 11:59 pm, **15th December, 2015**.

For any issues arising in contravention to such declaration, the Editorial Board shall not be liable. The author shall personally be liable for his or her actions or omissions.
